## 植物工場2工場における国際認証 GLOBALG.A.P.取得のお知らせ

株式会社バイテックベジタブルファクトリー（本社：東京都品川区、代表取締役社長：原田 宜）で取り扱う植物工場野菜の生産工場、株式会社バイテックファーム大館（拠点：秋田県大館市）並びに株式会社バイテックファーム七尾（拠点：石川県七尾市）が、この度、農業における国際認証である GLOBALG.A.P.（Good Agricultural Practice）を取得した事をお知らせいたします。

GLOBALG.A.P.とは、「食品安全」「労働安全」「環境保全」の実施を通じて、食の安全と持続可能な生産活動を実行する優良企業に与えられる世界共通ブランドです。現在、120カ国以上に普及しており、事実上の国際標準となっています。当社が掲げる基本方針「安心・安全な野菜の安定供給を通じた地方の活性化と業務用・加工用市場で革新を起こす」に沿って、世界標準での品質や信頼性を確保するため、GLOBALG.A.P.を実践してまいります。

当社の植物工場は、現在、鹿児島県薩摩川内市および石川県中能登町を加えた4工場が稼働しており、本年度中には秋田県鹿角市に工場を稼働させる予定です。他に類を見ない、業界で群を抜く植物工場事業者の実現に向け、来年には2カ所の全自動化工場を建設、その後、日産10万株以上の第8工場建設も計画しております。当社の植物工場野菜ブランド“デリシャスマイル”の大量供給体制を確立させていきます。今回の2工場以外においても順次認証を取得し、2020年の東京オリンピックに向けて、世界標準での安心・安全な野菜の安定供給を実現するとともに、企業価値の更なる向上を目指してまいります。
